**\*Service of Process:** The Tennessee Rules of Civil and Criminal Procedure require that all defendants to an action be properly notified that an action has been commenced. Service of Process can be had through the local Sheriff's department or through a private process server. The fees listed above that include Service of Process are those cases served through the Sheriff's department where the defendant is located. Parties may file an action without the Service of Process fee and employ the services of a private process server to meet the requirements of the rules of procedure.
